A registration is considered incomplete until Certificate of Insurance arrives and space **WILL NOT BE HELD**.
- LGP Organizers and the Vendor agree that all displays will be fully set up by ____ pm Friday, Jan. 31, 2014 and will be removed by ____ pm Sunday, Feb. 2, 2014.
- Vendor agrees to be open and staffed during the full length of the show.
- Vendor agrees that displays will not disturb aisles and/or adjacent exhibitors visually or physically.
- Vendor is responsible for any state and local permits.
- ALL Concession Vendors agree to and must have a Fire Extinguisher.
- LGP Organizers will not allow any Vendors to walk the grandstand areas selling your goods. Vendors agree to stay within their allotted space.
- Vendor agrees not to use the LGP logo or name on merchandise for sale without a written approval from the Lancaster Snow Drifters.
- Vendor agrees that no refunds will be made to exhibitors who fail to occupy space. Refunds will be made at the discretion of the Vendor coordinator.
- Vendor is responsible for the cost of moving in and out and is liable for any damage caused to the Sheraton Burlington hotel in connection with their exhibit.
- Vendor assumes responsibility for loss, theft, or destruction of goods or for personal injuries to him/herself, his/her employees, agents, representatives and will hold harmless LGP Organizers and the Sheraton Burlington hotel from any and all liability in connection with any and all of the above.
